**Location:** Coalinga Rifle Range, Derrick Blvd. <sup>3</sup>/<sub>4</sub> mile north of Jayne Ave., Coalinga, CA.

**Food:** A BBQ will be served after firing Saturday. Free to all competitors. Guest will be charged \$15.

**Entries**: ADVANCE ENTRY IS REQUESTED. All entries must be accompanied by full payment on the enclosed entry form. Entries will be accepted to the capacity of the range. Cancellations will be accepted and all fees will be refunded through 4 April.

**Eligibility:** Membership in the California Rifle and Pistol Association (CRPA) is required of all shooters. *Non-California residents* may purchase a 3-day CRPA membership for \$5. For competitors who do not meet these requirements, the fee for one-year CRPA membership is \$22. CRPA Junior membership is \$5. A membership application is attached.

**Camping:** The camping fee for RVs is \$12/night or \$60/week. Tent camping is \$5/night.

**Squadding:** All matches will be squadded. Squadding 0730-0800 every day.

**Classification:** The NRA classification system will be used in all matches.

**Sharing Equipment:** If two competitors wish to use the same equipment, their entry forms must be so noted.

**Pins:** Each competitor will receive a CRPA souvenir pin.

**Awards:** Awards will consist of cash. The California State Sercice Rifle Champion will receive the California BearTrophy.

**Award Restrictions:** A competitor may not win more than one award in any one match, other than a special award. There must be at least three competitors in each class for a first place award, seven for second place award, eleven for a third place award and fifteen for a fourth place award. In the event that there are fewer than three competitors in a class, they will be combined with the next higher class.

**Special Awards:** High Woman, High Junior, High Senior, and High Grand Senior will be awarded in the State Championship, provided there are three or more competitors who qualify for the award.

**Scoring/Target Service:** Competitors will score and pull targets. Any competitor who does not fulfill his or her scoring or target pulling duties may be disqualified.

**Targets:** All firing will be on appropriate NRA targets.

**Rules:** This is an NRA Registered match and NRA High Power rules will apply. It is the competitor's responsibility to be familiar with the current rules. Empty chamber indicators are required.

#### **Firing Schedule**

Every day: Squadding will be 0730-0800. Safety Brief 0800. Commence Fire 0830.

Thursday - Squadded Practice at 200, 300, and 600 yards.

Friday – Club Match, Regional Match Course with sighters

Saturday – State Service Rifle Championship,

Match 1 200 yards 2 sighters - 20 shots for record - standing - 22 minutes.

Match 2 200 yards 2 sighters - 2 minutes - 2 strings of 10 shots sitting in 60 seconds.

Match 3 300 yards 2 sighters - 2 minutes - 2 strings of 10 shots prone in 70 seconds.

Match 4 600 yards 2 sighters - 20 shots for record – prone – 22 minutes.

Match 5 California State Service Rifle Championship: Aggregate of matches 1, 2, 3, and 4.

National High Power Rifle Team Selections: "Membership on CRPA teams selected for national competition shall be determined by order of finish in the most recent state championship aggregate in that discipline from those competitors who are both a resident of California and a current CRPA member in good standing prior to the beginning of competition. A person accepting a position on a CRPA team agrees to abide by NRA and CRPA rules and any reasonable instructions from the team captain. Failure to comply may result in forfeiture of funding and debarment from participation in CRPA sanctioned activities for up to five years. Such disciplinary action may be imposed after a hearing by the Executive council upon receipt of a written complaint filed by the Chairman of the High Power Rifle committee."
