Work Party and Live Fire Practice Session

DATE: December 21, 2019 (SATURDAY) at Range 214

GENERAL INFORMATION:

RANGE LOCATION: Range 214, Horno Range Complex, MCB, Camp Pendleton, CA. Refer to SMGC web-site (www.smgunclub.org) for Camp Pendleton vehicle entry requirements and detailed driving directions to the range.

WORK PARTY: The Santa Margarita Gun Club will be conducting our 3rd Work Party to finish the last of our target frames for our Electronic Target Systems. This work party is dedicated to completing the last amount of work to get our systems and targets finished. Since the majority of targets frames are built already, we will need to attach the electronic sensors onto the remaining target frames and build the target repair faces for the short and long line events.

WORK PARTY START TIME: 8:30 A.M. on Saturday, December 21, 2019.

PRACTICE SESSION: Upon completion of the work party, (Approximately 12:00 noon) SMGC Members will transition to the Live Fire events. The club has invested a vast majority of our club funds to these Electronic Targets so that we would be able to eliminate the need for target pullers at our future events.

One of our main purposes of this Practice Session will be to get members who attend and desire to shoot, familiar with the two different Electronic Targets Systems (Shot Marker and Silver Mountain Target Systems) along with Match Officials to overcome any problem areas. Firing Members will need to bring their own personal electronics (Tablet, I-Pad, Lap Top Computer and/or Smart Phones) to the practice session. The course of fire is listed below.

<u>Live Fire Practice Session Fees:</u> SMGC Members Participants \$ 10.00 for all members. Registration will be required on **Practiscore** on the club's website.

<u>Note</u>: All Competitors/rifles (Service/Match/Palma/F-Class Rifles) will be firing on the targets which they build. The use of Chronographs will be allowed at the 500 yard line.

Work Party Supplies and Equipment Needed:

Members are requested to bring with them the following items (1, 2 and 3):

- 1. Work Gloves
- 2. (1) can of 3M Spray Adhesive to attach future replacement Target Centers
- 3. (1) Razor Blade type-Cutting device, to cut cardboard.

Additional Tool Items Needed:

- 4. Cordless Drill and Phillips Screw Head attachment and spare Batteries (Not required for everyone to bring 4 Needed)
- 5. 36" or Longer Straight Edge Metal Ruler or Level (Not required for everyone to bring 4 Needed)
- 6. Snap/Chalk Line (Not required for everyone to bring 4 Needed)
- 7. Large Plastic spreader (Not required for everyone to bring -10 each Needed)

RIFLE TYPES ALLOWED at the practice session:

NRA Service Rifle, NRA Match Rifle, Palma Rifle or NRA F-Class rifles are allowed.

SAFETY EQUIPMENT: Hearing Protection, Eye Protection, and Empty Chamber Indicators (ECI) or Empty Chamber Flags are **mandatory**. ECI's may be purchased at the range for a cost of \$ 2.00.

<u>AMMUNITION</u>: Competitors must supply their own factory ammunition. If placing ammunition in MTM Ammo Containers, be sure to bring at least one box of ammunition in its factory container with the lot number. **Tracer**, **incendiary or armor piercing ammunition is prohibited** (Rule 3.17(b) applies).
